The Mendip Caving Group is in the process of converting from registered charity 270088 to Charitable Incorporated Organisation 1197325. The new CIO has now been created. The initial trustees of the CIO have already voted to admit all the members of the old charity to the CIO, at the equivalent membership class and to transfer their length of membership of the MCG to the CIO.

The old charity is governed by the MCG's old constitution and the CIO by its new constitution. Members voted to complete the conversion to a CIO, and to approve its new constitution as a CIO, at our 2021 AGM. A consequence of this conversion is that we must today, actually hold two AGMs, one for the old charity and one for the CIO. The bulk of the AGM business will be conducted within the CIO's AGM. We need though to elect some committee members for the old charity so that they can authorise its eventual closure. The AGM of the old charity will be held first with the CIO AGM following on immediately afterwards.
