Our AGM is an important event at which we review our activities over the previous year and make plans for the future. Attendance by as many members as possible is welcome and indeed essential, if MCG is to thrive.

We are still looking for nominations for the posts of Librarian/Recorder and Editor or Tackle Master. It is important that we have volunteers to fill these posts. We would also like some help with the maintenance of our website. Please let the secretary know as soon as possible if you want to volunteer for one of these or indeed, any trustee posts. For the record, I do not intend to stand as Secretary for 2024-2025 – I was elected in 2018, so 2023-2024 will be my sixth year.

The Mendip Caving Group is still in the process of converting from registered charity 270088 to Charitable Incorporated Organisation 1197325. We have not yet completed the transfer of the investments and the title of the cottage to the CIO – it's taking longer than we thought. We can't close the old charity until these transfers are complete.

The old charity is governed by the MCG's old constitution and the CIO by its new constitution. A consequence of the ongoing transfers is that we must today, actually hold two AGMs, one for the old charity and one for the CIO. The bulk of the AGM business will be conducted within the CIO's AGM. We need though to elect some committee members (trustees) for the old charity so that they can authorise its eventual closure. The AGM of the old charity will be held first with the CIO AGM following on immediately afterwards.

6. Election of trustees for 2023-2024

The CIO constitution provides for a maximum of twelve trustees. Many, but not all, of the trustees, are involved in the day-to-day running of the MCG. All the trustees will be invited to and may join, any meeting of the trustees. Those listed in the table below with a role of Custodian are not expected to take part in the day-to-day running of the MCG. Their expertise may be called upon by the other trustees when needed, or they may offer help if the other trustees experience particular difficulties. Practically, during 2022-2023, the Custodians have helped us achieve a quorum (more than half) for trustee meetings and helped with our decision making. According to the CIO constitution, one third of the trustees must resign annually but may stand for re-election. The trustee nominations for 2023/2024 are shown in the table below.

We must vote to adopt this amendment or retain our existing constitution.

Mark Edwards proposes that we amend the trustee meeting quorum sentence in para 19 (3) (a) from

The quorum is more than half of the total number of charity trustees, or such larger number as the charity trustees may decide from time to time.

To

The quorum is a minimum of five charity trustees, or such larger number as the charity trustees may decide from time to time.

Thae background to this is that when preparing the CIO constitution, we did not envisage that we would routinely elect twelve trustees, rather

eight or nine. Extra 'custodian' trustees were elected in our 2022 AGM, in part as signatories for investments. At that time, we did not expect them to be involved in the day-to-day management of the MCG. We had some trouble getting seven trustees together at the same time for a virtual meeting during 2022. We had one meeting that was not quorate. Needing just five trustees would make it easier to form a quorate meeting.
