Our CIO constitution provides for a maximum of twelve trustees. Many, but not all, of the trustees, are involved in the day-to-day running of the MCG. All the trustees will be invited to and may join, any meeting of the trustees. Those listed in the table below with a role of Custodian are those not expected to take part in the day-to-day running of the MCG. Practically, during 2024-2025, the Custodians have helped us achieve a quorum (at least half) for trustee meetings. According to the CIO constitution one third of the trustees

must resign annually but may stand for re-election. The trustee nominations for 2025-2026, as of 1^{st} March 2025, are as shown in the table below.

Addendum

Proposed rules for exclusive use booking.

- 9. Exclusive use of Nordrach cottage
- 1) Our constitution states that the trustees may, from time-to-time, prohibit member's overnight occupancy of the CIO premises, to enable the premises to be used by a youth organisation whose safeguarding rules would prohibit the overnight presence of persons outside of their organisation. Such bookings help fulfil our charitable remit and provide welcome income for MCG. This section of the rules aims to define the meaning of **time-to-time**, **overnight** occupancy and **youth organisation**. Remember that these rules, as well as enabling the safeguarding of our guests, also help protect members from false accusations.
- 2) On no more than three occasions per calendar year, the trustees may permit a whole cottage (exclusive use) booking, of up to 7 nights, including a Friday and Saturday night. Such bookings will:
 - a) be well separated through the year
 - b) not be accepted for extended, public holiday, weekends.

- 3) Further, mid-week (Sun-Thurs night) exclusive use bookings, well separated from any other exclusive use bookings, may also be accepted at the discretion of the trustees.
- 4) Because of the safe-guarding needs of such groups, MCG members will be unable to stay overnight at the same time and must co-operate with the group for daytime access. In particular:
 - a) members must be absent from the MCG cottage (but not its outbuildings) between 8PM and 8AM
 - b) members must co-operate with the organisation's leaders for access to the lounge, library, toilets and kitchen between 8AM and 8PM
 - c) members should not use the changing rooms or showers at any time during an exclusive use booking
 - d) the leaders of an exclusive use group are empowered to exclude MCG members from the MCG cottage, between 8PM and 8AM during their booking
 - e) the leaders of an exclusive use group are empowered to exclude MCG members from the changing rooms and showers at any time during their booking.
- 5) The trustees will use their best endeavours to communicate the dates of any exclusive booking to the full MCG membership in a timely manner, giving at least one month's notice and repeating the notice one week before the booking. Such notice is to be given by email, directly to members and be posted on MCG social media.
- 6) Exclusive use bookings will not be accepted for youth organisations that are not formally constituted.
- 7) By way of further definition, a youth organisation is "an organisation that works with children and young people, where the majority of the children are aged 11 to 18 years and are registered with their appropriate regulatory body." Included categories are:
 - Charities registered with the Charities Commission
 - Not-for-profit companies (including CICs) registered with Companies House
 - Schools
 - Local authority youth services
 - Uniformed organisations
 - Sports clubs
